Additional Fees

Security is required for all weddings. It is solely PebbleCreek's decision on how many guards are required. Security is \$20.00 Per Hour, Per Guard.

A one-time bar set up fee of \$150 will be applied for each bartender. It is solely PebbleCreek's decision on how many bartenders will be required for the Wedding. No Outside Bartenders or Alcohol Permitted. A fee of \$250 will be applied if any outside alcohol is brought onto the premisses.

Parties over 200 may incur additional fees for setup, clean up, additional staff and equipment rental, if needed. Decoration Fee of \$250 Applied When Using PebbleCreek Centerpieces

Food & Beverage

All food and beverage is provided and prepared by the PebbleCreek Catering Department and is not to be removed from the property under any circumstance. With the exception of cake and desserts, no outside food or beverages are allowed. All bar and liquor services close one hour before the wedding is scheduled to end and are limited to 4 hours, no exceptions.

Food and beverage is subject to 10.31% sales tax and 22% service charge. Menu prices are subject to change, and are not guaranteed any sooner than 90 days. The final count is due seven (7) business days in advance of your event, and once given, is not subject to reduction. An increase may be

accepted within 7 Days of the wedding with a non-negotiable fee of \$125.00. A Menu tasting is provided once a date is secured by a signed contract. The menu tasting occurs within 3-6 months of the wedding date.

Venue Policy

You may provide any room decorations that you wish to both the ceremony and reception space. However, we do require that nothing is attached to the walls. Candles are allowed, but do require a sufficient enclosed base to avoid dripping of wax on the table linens. Unless contracted with PebbleCreek, all decoration provided by yourself or an outside vendor, in addition to any set up/break down of those items, is solely your responsibility and must be removed from the property at the end of the event day. PebbleCreek does not permit the release of Chinese lanterns, sparklers, or allow rice to be thrown on property. In addition, to protect the health of the animals and the upkeep our lawns, we require that any flowers that are used outside, are real and not artificial unless securely attached to the chairs and/or arch. All weddings must end at 11:00pm, no exceptions.

Golf Course Over-Seed Schedule

Each year the golf courses at PebbleCreek undergo what is called "over-seeding" to ensure beautiful, lush lawn throughout the winter. This process begins Mid-September and continues through Mid-October. During this time, a lawn ceremony is not permitted. Please note that the over seeding process can and may be affected by Mother Nature, and cannot be guaranteed by any given date.

Billing & Booking

The event is to be paid in full, one day prior to the wedding date, no later than 12noon. Billing will be based on the final guaranteed number or actual attendance whichever is higher. A 50% payment, based on all estimated charges is due 90 days prior to the wedding. To reserve a date, a deposit of \$500.00 is required along with a signed contract. The deposit is non-refundable once paid, however the deposit can be transferred to another date within the same calendar year upon availability
